

MEDIA RELEASE – EMBARGOED AND NOT FOR USE PRIOR TO WEDNESDAY 5TH APRIL, 2017

Over 100 charities band together demanding Australia's fundraising regulations are fixed by the Federal Government, highlighting current regulations work actively against a massive sector that now employs over 1.1 million Australians and has over \$134 billion in annual revenue.

Community Council for Australia (CCA) Chair Tim Costello says many charities now ignore the current funding regulations because they are too confusing, too complex and highly ineffective. CCA estimates less that 10,000 out of Australia's 50,000 charities even comply with current rules. Tim Costello says millions of dollars are being wasted in lost productivity because of the almighty mess.

Over 100 major charities have joined together to call on the Federal Government to fix Australia's fundraising regulations – which they are say are "an almighty mess" and are directly leading to tens of millions of dollars in lost productivity being wasted in the charity sector annually.

Tim Costello – the Chair of Community Council for Australia – is helping to spearhead the call for the change. He says Australia's charity fundraising regulations are completely out of date and work actively against Australia's massive charity sector.

Community Council for Australia (CCA) highlights the charity sector now employs a massive 1.1 million Australians with over \$134 billion in annual revenue and \$11 billion alone in individual giving.

Tim Costello says bluntly put, many charities now ignore the current rules because they are simply too confusing, too complex and highly ineffective.

He estimates that less than 10,000 out of 50,000 charities even comply with the current rules. He highlights changes would save the States and Territories running their own compliance branches.

Tim Costello says the sector has been asking the Government to fix fundraising in Australia for 20 years. He says that it seems that whilst cutting red tape is essential for business, the Government has not prioritised cutting red tape for charity.

Signatories demanding fundraising reform include The RSPCA; The Smith Family, World Vision, Australian Council of Social Service (ACOSS); CPA Australia; Australian Institute of Company Directors; Philanthropy Australia and Community Council for Australia. Organisations behind the call include Law Council of Australia; Mission Australia; Oxfam Australia; SANE Australia; Save the Children and a massive list of other charities.

An open letter will be delivered to Government on Wednesday 5th April, 2017.

Tim Costello said, "Charities want to do the right thing but the rules work against them. It is more than time to fix this. A key point is that it can be done easily **at no cost.** Federal, State and Territory Governments need to provide charities with one nationally consistent modern and fit for purpose fundraising regime as part of the current review of Australian consumer law."

David Crosbie – the CEO of Community Council for Australia – said, "Charities across Australia are completely frustrated with Governments not acting to remove red tape and duplication that is costing hundreds of millions of dollars in lost productivity. **Charities have had enough.** When it comes to freeing up charities to do their work, responsible Ministers fall into the arms of ill-informed bureaucratic advisors. They wave more forms in our faces. It's laughable. Fundraising regulations are a classic example of feral bureaucracy. They are a dog's breakfast of regulations costing hours of staff time in wasted compliance activity."

Tim Costello said, "There have been numerous independent enquiries all asking for change yet we seem to be told this issue is not important enough. It is just not good enough. Our charities deserve better."

"The charities of Australia support and enable so many aspects of our lives. They work in education, the arts, health, emergency services, the environment, employment, housing, health and so many other areas. They are crucial to Australia's productivity and Australia's well-being."

"We need action now so that our organisations and the donors who support us can actually operate under a twenty-first century nationally consistent and fit for purpose regulatory regime. We are calling on Governments to fix the fundraising mess so we can get on with what we do best – which is building flourishing communities."
